Minutes of the Meeting held under the Chairmanship of Hon'ble Minister for Rural Development & Panchayati Raj, Law, Justice & Parliamentary Affairs on 19-08-2011 at 11.00 AM.

A meeting was held under the chairmanship of Hon'ble Minister for Rural Development /Law, Justice and Parliamentary Affairs on 19-08-2011 at 11.00 AM in his office chamber regarding Inspection Report of Quality Monitor's MGNREGA of Jammu/Kashmir divisions.

The following officers participated in the meeting:-


1. Additional Secretary to Government, Rural Development Department.
2. Director, Rural Development, Jammu/Kashmir.
3. Superintendent Engineer, REW, Kashmir.
4. Member Secretary, MGNREGS.

In the meeting, the following decisions were taken:-

- a. The reports of SQMs shall be furnished to the Directors of Rural Development Jammu/Kashmir who will send their reports along with the recommendations to the Administrative Department within a week's time. It was decided that Directors will also examine the reports, whether the guidelines have been followed while executing the works at gross-root level by the State functionaries.
- b. All Payments under MGNREGS viz Labourer, Skilled manpower as well as material used shall be made through account payees

cheques. Director Rural Development Kashmir /Jammu shall ensure the monitoring of the same on ground and ensure all relevant documents are maintained as envisaged in the scheme/Act at grass root level.

- c. Since the term of State Quality Monitors has expired in the month of July 2011, it was decided that fresh advertisement shall be made for engaging the SQMs. Requisite qualifications must be advertised for ensuring selection of proper monitors.
- d. For effective implementation of MGNREGS, decision regarding the engagement of supporting staff was taken under the Chairmanship Hon'ble Minister for Rural Development Department/Law, Justice and Parliamentary Affairs on 13-14 August 2010 and subsequently the decisions of the Executive Committee on 14-10-2010 that one GRS shall be engaged in each panchayat halqa, one Technical Assistant per five panchayats. The decisions of the Executive Committee were ratified in the 3rd meeting SEGC held on 19-04-2011. Rural Development Department shall, therefore, explain why the decisions weren't implemented verbatim. It was further decided that necessary instructions as per the decisions of SEGC may be conveyed to the Directors, so that necessary manpower is engaged.
